The history course has four grades which include three exams and one major paper. For the history course, students have three exams and one major paper.

	I taught two courses in Humanities 3303. The students had five single page assignments, three exams, and one major paper. I taught one course of History 1301. The students had one major paper and three exams.

	I taught two History 1301 courses and one History 1302 courses. The students for each course were assigned three group assignment grades and three test grades.
Fall: August-December 2013	University of Texas at El Paso: Lecturer
	I taught one class of History 1301 and one class of History 1302. The students have three exams and one major paper. I taught two Humanities 3303 classes. The students have five single page assignments, one major paper, and three exams.
	El Paso Community College: Adjunct Instructor
	I taught three courses of History 1302. The students had three group assignments and three exams. The assignments and exams also focus on creating a thesis statement and providing proper support.

University of Texas at El Paso: Lecturer

At UTEP I taught two courses of Humanities 3303 Challenges in Modern Culture from 1600-the Present. I designed the lectures and complimentary power points for the course. I first addressed the historical context that applied to the development of a particular cultural period/ genre. I select the works of art, literature, music, philosophy, architecture, and film that fit the theme of challenges to modern culture. I emphasized the interconnections between the disciplines. The class discovered how innovators break from the mores and ideals of the past to create new ideals in various disciplines. Then we delved into how the different disciplines influenced each other and how they were influenced by the historical context.

I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students.

El Paso Community College: Adjunct Instructor

I taught two courses of American History 1301 from the Beginning to 1865. I planned the scope and sequence of the course in a syllabus. The course readings were constructed to relate to the lectures and complimentary media such as video, music, art, and poetry. I designed the reviews, exams, and assignments. I graded all the assignments and exams. I kept account of students' grades. I tutored and guided the students during daily office hours. I directed the classes on how to do the assignments and study for the exams. The course was designed to delve into the roots of our current events and culture, so that the students may realize how history is relevant to their present lives. As a class, we uncovered how there is also persistence and change in our culture.

Fall: August – December 2012 University of Texas at El Paso: Lecturer

I taught two courses of Humanities 3303 Challenges in Modern Culture from 1600 to the Present. I required five single spaced single page papers throughout the semester. The students were required to answer the questions for each paper based on the assigned readings. The questions required the students to think critically about the text. They also have a major paper, five page long, based on a list of topics that they can write on. It must be an analysis of a collection of works based on a cultural period such as Romanticism. The exams require an essay and five IDs where they describe who, what, when, where, why, and the significance in a paragraph. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students.

El Paso Community College: Adjunct Instructor

I taught two courses of each American History 1302 from 1865 to the Present and American History 1301 from the Beginning to 1865. In all of my courses I focused on cultivating the writing and analysis skills of my students. I included essential questions in my power point presentations to guide the students. Essential questions help them grasp the important information they need to know and it makes the lecture more relevant to them. I did all of the following: design the lectures, create the power points, design the exams, design the assignments, grade, and record the grades.

### Summer: July-August 2012 El Paso Community College Summer Semester II: Adjunct Instructor

I taught American History 1301 From the Beginning to 1865 and American History 1302 from 1865 to the Present. In all of the American History classes, the students were assigned three group assignments based on questions about a debate in history. Each student was required to contribute a thesis statement and three paragraphs of support. Then they were required to come up with a group consensus. If they did not have a consensus, they had to discuss their different opinions. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students.

June-July 2012	El Paso Community College Summer Semester I: Lecturer
	I taught American History 1301 From the Beginning to 1865. Before I present a documentary in any class, I have a list of broad questions that require the students to actively think about what they are watching. There is a discussion about importance of what they are going to watch. Then there is an open discussion after the documentary. The material covered in the documentary is put into the exam. The essential questions for the documentary are offered as an essay question in the exam. This is done for all of the courses. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students.
January-May 2012	University of Texas at El Paso: Lecturer
	I taught two courses of Humanities 3303 Challenges in Modern Culture from 1600 to the Present. All assignments were written assignments that required the students to have a thesis statement and support. I evaluated the quality of their thesis statement and the structure and clarity of their support. I posted credible web sites, documentaries, and films on Blackboard that enhanced their understanding of the course. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students. I also role modeled how to conduct an analysis of art or literature for the students because that is what is expected of them in their written assignments. I do this in all of my classes.
	El Paso Community College: Adjunct Instructor
	I taught two courses of American History 1301 and one course of American History 1302. In the group work, each student contributed their response to a question based on a debate in history. Their response required a thesis statement that is specific and concise. Their body of support had to be well cited, structured, and organized. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and recorded the grades. I kept office hours to tutor and guide the students.

August-December 2011	University of Texas at El Paso: Lecturer

I taught one course of American History 1301, one course of American History 1302, and one course of Humanities 3303. The American history courses at UTEP require four grades. They are given 3 exams and a five page paper. The five page paper is an analysis of primary sources on a particular topic. The American History 1301 had 125 students so I was given a teaching assistant to grade the exams and major papers. However, for the rest of the classes I graded all the assignments and exams. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and record the grades. I kept office hours to tutor and guide the students. I brought in art, literature, song, and video that relate to the lectures. We analyzed how these types of media related to history.

El Paso Community College: Adjunct Instructor

I taught two courses of American History 1302 and one course of American History 1301. In all the classes the exams have a section one that must have a thesis statement and a body of support. The section two had IDs that student must respond to in one paragraph. I teach all of the classes how to study and prepare for section one by instructing them how to do an outline. This provides the students a clear and structured manner to study and it helps their study and writing skills.

June-July 2011	El Paso Community College: Adjunct Instructor
	I taught one course of American History 1302. Music, literature, and art were integrated into the lecture. We analyze together as a class how a particular piece of creative work reflects its historical context. One example would be Billy Holiday's performance of "Strange Fruit." We then discuss how her performance relates to lynching and acts of resistance to oppression. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and record the grades. I kept office hours to tutor and guide the students.
January-May 2011	University of Texas at El Paso: Lecturer
	I taught one course of Humanities 3303 Challenges in Modern Culture. This course required eight single spaced single page

I taught two courses of American History 1301 and one course of American History 1302. In all of the American history courses for El Paso Community College there are six grades. Three of the grades are the group assignments that are centered on a debate in history. Three are in class exams that are done individually. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and record the grades. I kept office hours to tutor and guide the students.

# August-December 2010 University of Texas at El Paso: Lecturer

I taught one course of Humanities 3303 Challenges in Modern Culture from 1600-Present. I had the students write eight single spaced single page papers on each of the readings. Plus, they had three exams in the semester that were all essay. I kept office hours to guide and tutor my students. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and record the grades.

El Paso Community College: Adjunct Instructor

I taught two courses of American History 1301 and one course of American History 1302. For every course, I kept about an hour or 90 minutes of office hours daily to conference/tutor my students. I also designed and graded the assignments, the test reviews, the tests, power points. I created the grade charts and record the grades.

August-July 2010 University of Phoenix: Adjunct Instructor

I taught one course of American History from 1865 to 1945. The course had a non-traditional structure compared to lecture courses at most universities and secondary schools. The course meets once

	a week for four hours in a five week course. There is a mix of lecture, discussion, and group presentation, and activities to learn the material. They are required to do individual and group work such as writing papers and giving presentations. The course covers the following: Republican and Democratic political parties, Reconstruction, Industrialization, the Robber Barons, labor history, reform movements, agricultural history, Populism, cultural history, consumerism, World War I, the Jazz Age, the Great Depression, international and domestic politics during the Great Depression, the New Deal, and World War II.
January –May 2010	University of Texas at El Paso: Lecturer
	I taught Humanities 3303 Challenges in Modern Culture from 1600 to the Present. I synthesized several disciplines such as art, literature, economics, philosophy, and history. I presented how the various fields influence each other. I also address how each new generation of work is a response to the previous generation. I designed, graded, and recorded the grades for all the assignments and exams.
May-November 2009	School for Educational Enrichment: English, Art Appreciation, and Social Studies Teacher
	The School for Educational Enrichment is a private high school that offers students a chance to earn courses for credit in a one-on- one environment. This high school allows students more focused attention for those who desired to get ahead or catch up at the high school level. Each course provides 24 one hour classes. However, the Advance Placement courses require 30 hours and extra assignments. I instructed my students not only in content of the subject matter, but I also instructed the students in developing cognitive skills to prepare for college. I designed and graded the exams and assignments. I then evaluated the student's progress. I expected my students to learn about the writing process as well as literature and elements of literature for the English courses. My history courses required that students understand the significance of key figures, and events. I also taught them historical interpretation and analysis. In the art appreciation course, I taught my students to analyze the elements of art across cultures. The students were required to connect the art work to its historical and cultural context.

August-May 2009	University of Texas at El Paso History Department: Teaching Assistant for the Professor Cross and Dr. Jackson (World History A)
	For Professor Cross, I performed the following duties: attendance, proctor exams and quizzes, grade exams and quizzes, tutor students, grade essays, and address any student's needs for the course. I also averaged the grades and did the record keeping for the grades.
